## Introduction

The FTSE Europe Sector Select Index Series reflects the performance of mid and large cap European companies with the largest investable market capitalisations, as defined within the FTSE Europe Index and categorised by their respective ICB classification framework.

Indices may include a decrement version that will measure the performance of the index after taking into account dividend expectations and may include other costs such as transaction costs. The cost can be applied either as a number of fixed points to the underlying index value or as a fixed percentage to the underlying index returns.

The decrement levels used for each index are supplied by third parties and there may be more than one index with different decrement levels for any single stock.

All regional and country FTSE Russell indices are available to clients based on subscription level. The indices included in this document may not be available to all subscribers.
